## PROVINCIAL ASSEMBLY OF THE PUNJAB NOTIFICATION

23 February 2004

No.PAP-Legis-2(18)/2003/576. The Lahore College for Women University, Lahore (Amendment) Bill 2003, having been passed by the Provincial Assembly of the Punjab on 7 January 2004, and assented to by the Governor of the Punjab on 19 February 2004, is hereby published as an Act of the Provincial Assembly of the Punjab.

### THE LAHORE COLLEGE FOR WOMEN UNIVERSITY, LAHORE (AMENDMENT) ACT 2004

ACT III OF 2004

[First published, after having received the assent of the Governor of the Punjab, in the Gazette of the Punjab (Extraordinary) dated 23 February 2004.]

to amend the Lahore College for Women University, Lahore Ordinance, 2002.

Whereas it is expedient to amend the Lahore College for Women University, Lahore Ordinance, 2002 (XLIX of 2002), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. **Short title and commencement.**— (1) This Act may be called the Lahore College for Women University, Lahore (Amendment) Act 2004.  
(2) It shall come into force at once.

2. **Amendment in section 2 of Ordinance XLIX of 2002.**— In the said Ordinance, in section 2, after clause (o), the following new clause (o-a) shall be added:-

“(o-a) ‘Pro-Chancellor’ means the Pro-Chancellor of the University;”.

3. **Amendment in section 9 of Ordinance XLIX of 2002.**— In the said Ordinance, in section 9, after sub-section (6), the following new sub-section (7) shall be added:-

“(7) In the performance of his functions under this Ordinance, the Chancellor shall act and be bound in the same manner as the Governor of a Province acts and is bound under Article 105 of the Constitution of the Islamic Republic of Pakistan.”

**4. Addition of section 11-A in Ordinance XLIX of 2002.**— In the said Ordinance, after section 11, the following new section 11-A shall be added:—

**“11-A. Pro-Chancellor.**— (1) The Minister for Education, Government of the Punjab, shall be the Pro-Chancellor of the University.

(2) He shall perform such duties and functions and exercise such powers as may be assigned and delegated to him by the Chancellor.”

**5. Amendment in section 20 of Ordinance XLIX of 2002.**— In the said Ordinance, in section 20, sub-section (1)–

- (i) in clause (xiii), the word “and” occurring after the semicolon shall be omitted;
- (ii) in clause (xiv), the full stop occurring at the end shall be substituted by a semicolon, and thereafter the word “and” shall be added; and
- (iii) after clause (xiv), the following new clause (xv) shall be added:–

“(xv) three women members of the Provincial Assembly of the Punjab to be nominated by the Speaker of the Assembly.”
